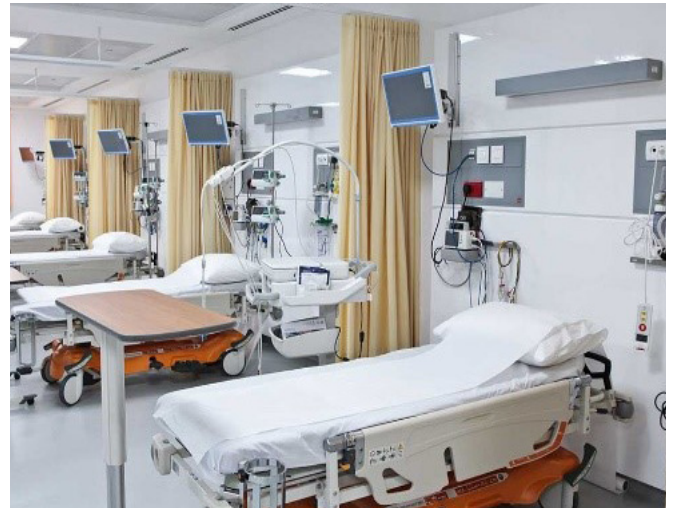
Family Law:

Health Sector

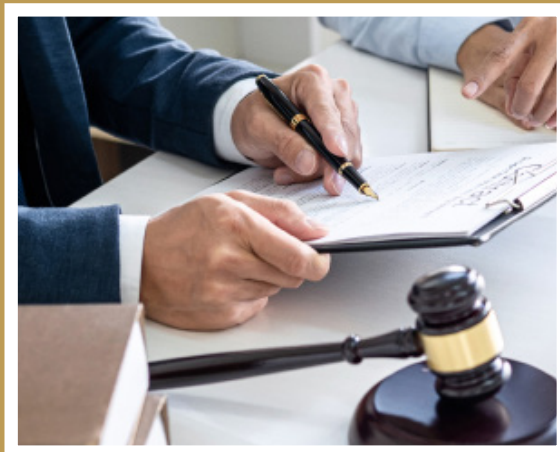

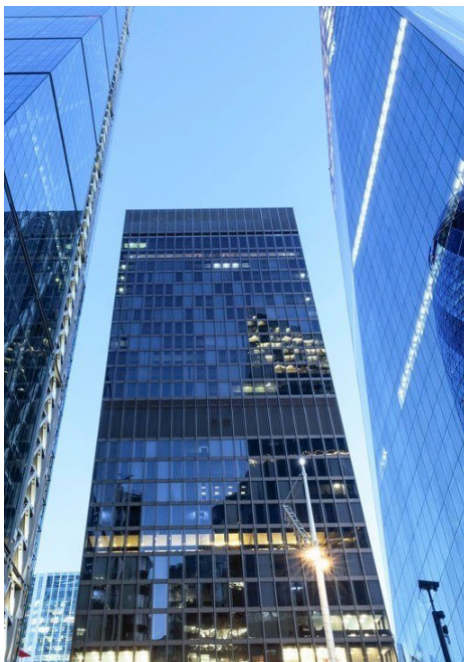
In addition, our team include lawyers who have strong involvement in alternative ways of dispute resolution such as mediation and conciliation.

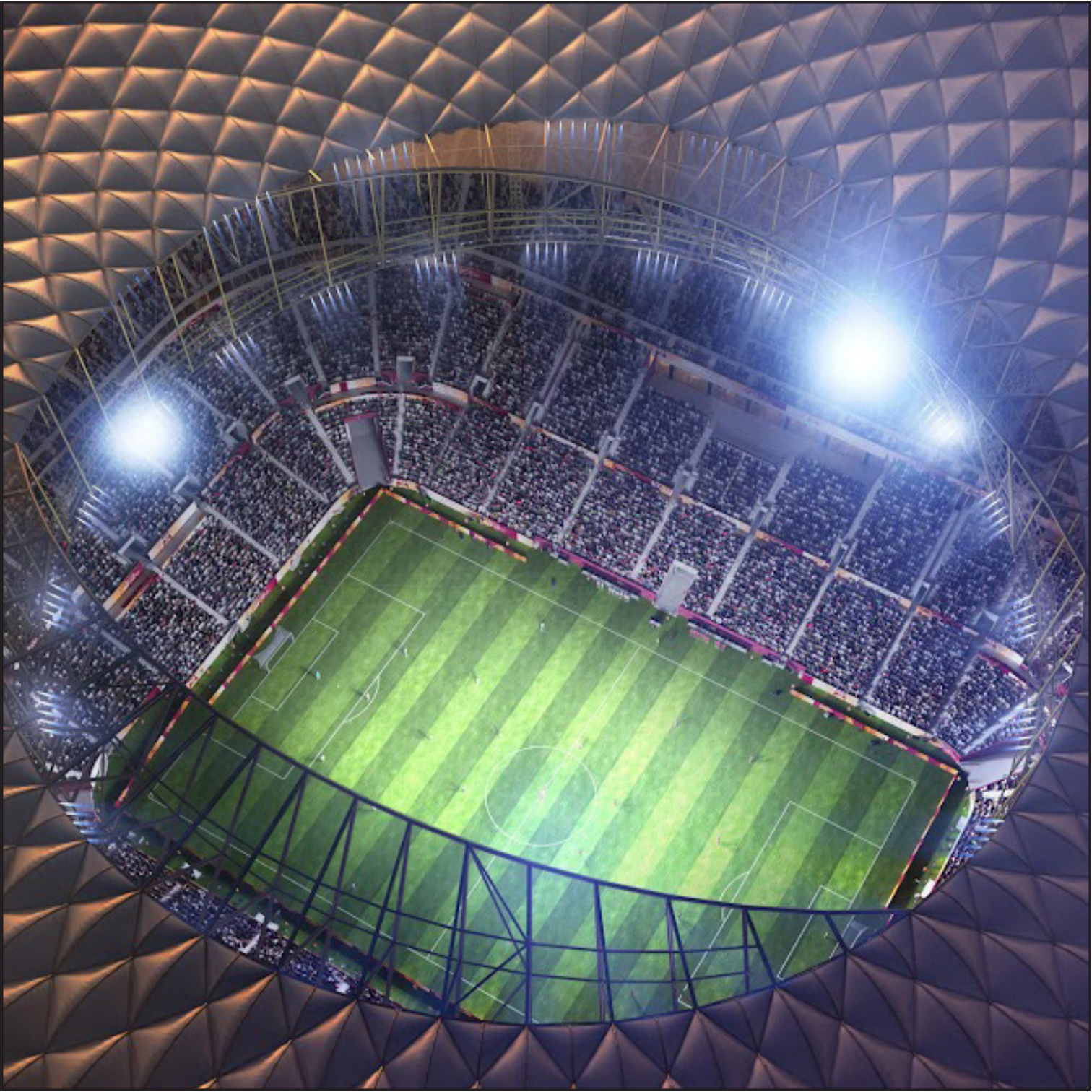


Real Estate:
